Savvy Consignment reserves the right to refuse any items not deemed suitable for resale.

All pricing will be established by *Savvy Consignment*; Savvy reserves the right to hold special sales or markdowns.

It is the consignors responsibility to track item expiration dates and to pick up any items that you want to retrieve. Any item not picked up becomes the property of *Savvy Consignment* and may be donated. Payment to the Consignor will be made in person at *Savvy Consignment* during regular business hours Monday-Friday. Payouts up to \$50.00 will be made in cash; payouts over \$50.00 will be made by check. Consignor commissions not collected within 2 years will be forfeited to Savvy Consignment.
